# **VA Paper Checks are Being Discontinued**

As a result of 31 CFR Part 208 - Management of Federal Agency Disbursements, VA will no longer issue paper checks after October 1, 2023. Instead, VA will distribute payments through the electronic funds transfer system (EFT), as required by law.

Any caregiver receiving paper checks from VA as part of the Program of Comprehensive Assistance for Family Caregivers (PCAFC) must enroll in direct deposit by October 1 to continue receiving stipend benefits.

Caregivers can enroll in direct deposit as a vendor through VA's Customer Engagement Portal. To complete the required form, caregivers will need their social security number, address, and bank routing and account numbers. Step-by-step instructions for enrolling can be found in the CSP Direct Deposit Enrollment User Guide.

For those without a financial institute, visit the Veterans Benefits Banking Program (VBBP) for options to receiving VA benefits via direct deposit without using a bank.

Primary Family Caregivers may also contact the VA Financial Service Center (FSC) Customer Care Center at 1-877-353-9791 for further assistance.

I encourage all VA beneficiaries who still receive a paper check from the VA to ensure they enroll in direct deposit by October 1. If you need assistance finding out how to set up a direct deposit, please contact our office and we can track down the appropriate form.


### Great Plains PVA at Nebraska Governor's Welcome Home Picnic

This past July the chapter hosted its annual Great Plains PVA Invitational Wheelchair Bowling Tournament. Even though it was the event's sixth year, there were a lot of firsts in this year's tournament!

- This was the tournament's first year at Mockingbird Lanes in Omaha. It was great to bring the event to Omaha and the staff at Mockingbird worked with us to make it a very positive transition for the bowlers.
- This was the first year we had an on-site pro shop open daily to assist tournament bowlers. A very special thank you to The Bowling Store and Pro Shop for their wonderful support throughout the 4-day event.
- The tournament was so pleased to welcome its first international team! Four bowlers from Sweden traveled over 4,500 miles to bowl with us. The bowlers and their support team immersed themselves in the tournament and many new friendships were made.
- This was the first year the tournament included a 3-person team event! Twelve teams of three wheel-chair bowlers competed on Thursday afternoon during a 3-game competition. Congratulations to the Swedish team for taking first place!
- This was the tournament's first year on the new National PVA Wheelchair Bowling Series. Under the new series rules, chapters sanction their tournament directly through the United States Bowling Congress (USBC) without collaboration with the AWBA. Thank you to the Bowling Store and Pro Shop for its training and assistance with sanctioning procedures.

This year's tournament was a record-breaking year with 42 bowlers from across the United States and Sweden competing. The tournament kicked off with Thursday's Doubles and 3-Person Team events. Eighteen teams of two competed in Doubles with the team of Jennifer Hooten and Curtis Wolff taking 1st place. Congratulations to Great Plains PVA members Will Leavitt and Chris Parnell for their 2nd place finish!

Twelve teams of three competed in the new 3-Person Team event with our own Great Plains PVA league bowlers making a great showing. Congratulations to the team of Mark Linquist, Randy Squier and Toodie Perry for their 3rd place finish. Congratulations also to James Beversdorf, Seth Kotouc and Gary Standley for finishing fourth.

The 3-day singles competition included both scratch and handicap divisions with ramp and non-ramp bowlers. Some bowlers were newer to the sport, others were returning champions, and some were members of the USA Para Bowling Team. It was exciting to watch the bowlers support each other and enjoy a common love for the sport. #### FEDERAL FUNDING UPDATE

Congress is back in session and much of their effort in September is focused on passing the 12 annual funding bills or a continuing resolution to keep the government open. The specter of a government shutdown has resurfaced, but we are hopeful lawmakers will act to prevent that from happening. As a reminder, much of VA is largely protected in the event of a shutdown thanks to the work of PVA and our veterans service organization partners to secure advance appropriations for the Department. We will be watching the budgetary process closely and provide updates when appropriate.

#### **VETERANS OMNIBUS PACKAGE BEGINS TO TAKE SHAPE**

The leaders of the House and Senate Veterans' Affairs Committees met during the August recess and reached an informal agreement on rules they will use to compile a package of veterans-related legislation into a single bill for passage later this year. They have yet to decide exactly which provisions would be included in the omnibus, but all four leaders have expressed a desire to include the Elizabeth Dole Home Care Act (H.R. 542/S. 141). We also understand that other provisions might focus on education, VA's electronic health record modernization project, and VA employee accountability. The Committees expressed hope in having the bill put together and passed prior to Veterans Day. Although

that is an ambitious timeline, PVA will focus on advocating for its passage prior to the end of the year.

#### HHS Issues Proposed Rule to Update Law That Prohibits Disability Discrimination

The U.S. Department of Health and Human Services (HHS) issued a proposed rule to update its prohibition against discrimination on the basis of disability under Section 504 of the Rehabilitation Act of 1973. Section 504, passed 50 years ago, prohibits disability discrimination in programs and activities run by federal agencies or that receive federal financial assistance. HHS is proposing to amend its existing regulations to outline obligations that are not explicitly addressed in Section 504. The proposed rule covers access to medical care, including nondiscrimination in life-sustaining care and participation in clinical trials; enforceable standards for medical equipment, including accessible weight scales and heights for medical diagnostic equipment; and the integration of people with disabilities into a setting most appropriate for their needs. The proposed rule also seeks to improve consistency with the developments of the Americans with Disabilities Act, such as requirements to maintain accessible features of facilities and equipment, permitting individuals to use powereddriven mobility devices in areas open to the public, and accessibility design standards for facilities. The comment period is open until November 13.

# SUPREME COURT WILL HEAR ADA HOTEL WEBSITE TESTER CASE IN OCTOBER

The oral argument for the U.S. Supreme Court case, Acheson Hotels, LLC v. Laufer, will be held on October 4. The question before the Court is whether a "tester" can bring a lawsuit for a hotel's failure to provide accessibility information on their website. Deborah Laufer, a mobility assistive device user and self-deemed "tester," regularly visits hotel websites checking whether they have information about physical accessibility. Under the Americans with Disabilities Act's (ADA) reservation rule, hotels must identify and describe the accessibility features of the hotel and guest rooms in enough detail for a guest to decide if the hotel will meet their needs. Laufer found that the hotel had no accessibility information on the website and sued, though she had no plans to reserve a room at that hotel.

The Court's opinion could impact when an individual has the right to sue under the ADA. PVA joined a brief to the Court, with 17 other disability rights organizations, to explain the importance of ADA lawsuits. Although PVA actively encourages advocates to work with the company and use other avenues for advocacy, the Supreme Court's ruling could determine when a person has the right to sue under the ADA. The audio and transcript of the oral argument will be posted on the Court's website.

# PVA AND CCD URGE AMTRAK TO HOLD NEW, ACCESSIBLE PUBLIC HEARING

Amtrak held a hybrid public meeting on Wednesday, August 30, to discuss accessibility for riders with disabilities, focusing on their new long-distance trainsets. After the meeting, Amtrak accepted comments on their website only until September 8. Unfortunately, Amtrak did not robustly advertise the hearing or the opportunity to submit feedback on their main webpages nor contact customers that had purchased tickets with disability accommodations in the past. As a result, very few people attended the hearing.

Danica Gonzalves, PVA Advocacy Attorney, attended the public hearing in person. Ms. Gonzalves is also a co-chair

for the Consortium for Constituents with Disabilities (CCD) Transportation Task Force. On September 8, Ms. Gonzalves and fellow CCD Transportation Task Force cochairs sent a letter with feedback to Amtrak. The letter emphasized how Amtrak failed to fully include passengers with disabilities in their public hearing. The CCD Transportation Task Force co-chairs urged Amtrak to hold a new, accessible public hearing that was widely advertised to riders with disabilities and reopen the comment period for feedback.

#### THE REHAB ACT TURNS 50

September 26 marks the 50th anniversary of the passage of the Rehabilitation Act of 1973, which prohibits discrimination on the basis of disability in programs receiving federal financial assistance or conducted by federal agencies, in federal employment, and in the employment practices of federal contractors. A powerful law in its own right, the law also paved the way for the Americans with Disabilities Act and other advancements in disability rights.

In addition, the Rehab Act created the Independent Living Services program, the Centers for Independent Living program, and the National Institute on Disability, Independent Living, and Rehabilitation Research, all of which are part of the Administration for Community Living (ACL) today.

While there is still work to be done, the law shepherded a new era in disability rights and it serves as a cornerstone in a foundation we continue to build upon today. Updates on actions being taken in honor of the anniversary will be shared via <u>ACL Updates</u>.

#### LEGISLATION ESTABLISHING ADVISORY COMMITTEE ON ACCESSIBILITY IN VA INTRODUCED IN THE SENATE

Prior to the August recess, Senator Bob Casey (D-PA) and Senator Rick Scott (R-FL) introduced S. 2516, the Veterans Accessibility Act of 2023. This legislation would create a VA advisory committee to assess the accessibility of electronic information, buildings, facilities, structures, services, and benefits, as well as

care furnished by health care providers. The committee would be tasked with collecting recommendations to improve compliance to federal accessibility laws such as sections 501, 504, and 508 of the Rehabilitation Act of 1973, the Americans with Disabilities Act, and other laws to ensure equal access to buildings, benefits, and services for people with disabilities.

PVA supports the legislation and worked extensively on the draft bill. We are currently supporting efforts to have this legislation introduced in the House.

#### **VA HOLDS CONFERENCE ON WOMEN'S HEALTH**

At the beginning of September, VA held the Women's Health Services Research Conference. This is the second time the event has been held. It brings VA providers from across the country together to discuss new research being conducted around women's health.

Topics covered included using evidence-based interventions to treat post-partum depression, mental health concerns, aging care and menopause treatment, as well as suicide prevention and labor force participation. Several breakout sessions were held that focused on a range of fields such as reproductive health, addressing trauma and harassment, delivering women veterans' health care in rural areas, as well as engagement and retention of women within the VA system of care.

This was the first conference dedicated to women's health held in nine years and VA hopes to hold the event more frequently in the future. The research conducted by VA on women's health has lasting implications in the broader health care arena.

#### **News of Note**

#### **September is National Voter Registration Month**

The National Association of Secretaries of State (NASS) wants to remind citizens that September is <u>National</u> <u>Voter Registration Month</u>. Every September since 2002, NASS recognizes this month to encourage voter

registration and to recommend existing voters check and update their registration status, if needed.

# DOJ Finds Two New Jersey VA Homes Subject Residents to Harm and Risk to Deadly Infections

The U.S. Department of Justice (DOJ) Civil Rights Division and U.S. Attorney's Office for the District of New Jersey recently concluded an investigation of two veterans' homes, operated by the New Jersey Department of Military and Veterans Affairs. DOJ investigated the facilities to determine whether there was a pattern or practice of a deprivation of constitutional rights, under a federal law that applies to state and local government-run residential institutions. The investigation found the homes have inadequate infection control practices and inadequate medical care, compounded by a lack of effective management and oversight, that exposed residents to unreasonable harm and risk for serious and deadly infections. The investigation determined these practices resulted in increased resident deaths.

Following its investigation, DOJ recommended the state implement adequate infection control procedures, systematically provide medical and physical care consistent with accepted professional standards, maintain valid and reliable quality management data, and implement oversight and accountability mechanisms. DOJ plans to work with the New Jersey Department of Military and Veterans Affairs to improve the conditions in these homes and ensure veterans and their families receive the care they need and deserve.
